We significantly increased our number of participants and sponsorship at the 2K/10K. New things this year included World Book Day Film Night which was well received, whilst not being a big earner, plus refreshments on Fridays in the summer term and at sports day, which was popular with pupils but relied heavily on a small number of helpers. We trialled two new retailer incentives (garden centre cards and personalised lego) and planning on Christmas cards for 2019.




